Non-academic Notes:

Severance paid out using earnings codes LNR and TAG will be charged only health(dental & medical), unemployment , FICA, and Medicare.
Settlement payments using earnings code SEE will be charged , FICA & Medicare. Settlement payments using SEN will be charged FICA & Medicare.

Academic Notes:

Severance paid out using earnings codes LNR and TAG will be charged only health, unemployment , FICA, and Medicare.
Academic salaries paid using earnings codes ATL, ECX, IST, MOR, DUC, ROC, EBX, EAX, OLE, OME, SEN, and SSS will be charged FICA and Medicare.
Payments using earnings code CON will be charged Medicare only.
Payments using earnings code NON will not be charged any fringe.
Settlement payments using SEE will be charged FICA, Medicare.
Payments made outside base appointment term dates using SMR will be charged FICA, Medicare and retirement.
Payments made outside base appointment term dates using SMZ and GRD will be charged FICA and Medicare.
Payments using earnings code SPO will not be charged faculty retirement..

Other Notes:

If a student has a F1 or J1 visa, the first five calendar years (based on arrival date in the U.S.) are exempt from FICA and Medicare.
If a non-student employee has a J1 scholar visa, the first two calendar years (based on arrival date in the U.S.) are exempt from FICA and Medicare.
